SAFE CHURCH COMMUNITIES ORDINANCE 2009

(Amended 2010, 2011, 2013;

Schedule 1 amended March, September, December 2014, September 2016, Synod 2019, June 2020, Apr 2021, Sept 2021)

BE IT ENACTED by the Bishop, Clergy and Laity of the Diocese of Tasmania in Synod assembled, as follows:

- 1. This Ordinance may be cited as the "Safe Church Communities Ordinance 2009".
- 2. Recognising the commitment of this diocese to ensuring our church communities are safe places for all, the objects of this Ordinance are:
 - to establish a system whereby church workers are authorised as holding current endorsement to exercise certain ministries in the diocese within the framework of Safe Church Communities;
 and
 - b. to describe the requirements for endorsement for church workers, whether holding the Bishop's licence or not, to serve in their prescribed office or role in the diocese.

3. In this Ordinance:

"Church Worker" has the same meaning as that given in the 'Professional Standards For The Protection Of Children And Adults from Sexual Misconduct Ordinance 2005', whether that person holds the Bishop's licence or not,

"Disclosable Matter" means

- the Church Worker being charged with an offence that would be punishable by 6 months imprisonment or more if the offence was or were to be committed in Tasmania;
- The Church Worker being convicted or found guilty of an offence that would be punishable by any term of imprisonment if the offence was or were to be committed in Tasmania.
- An Australian court making a finding against the Church Worker in relation to violence against a family member or a child or an order under the Family Violence Act 2004 (Tas);
- The Church Worker becoming aware of a notification being made against him or her to any Child Protection Authority; or
- A finding against the Church Worker of a licensing board or a professional board that relates to a complaint of a sexual nature.

"Safe Church Communities" means the program of training and endorsement for safe ministry as approved by the Professional Standards Committee for use in the diocese and includes "Faithfulness in Service' the code of ethics which forms Schedule 5 of the 'Ministry and Tribunal Ordinance 1998 Amended 2007'

"Ministry" for the purposes of this Ordinance means those ministries in which those persons represented in Schedule 1 are engaged.

4. Church Workers listed in the attached Schedule 1 are required to hold the endorsement under the *Safe Church Communities* program as set out in the attached Schedule 1 as a condition of exercising their ministry.

(Amended 2019) 4A. Ongoing Reporting

- (a) If any Disclosable Matter occurs in respect of a Church Worker, that person must report that matter to the Director of Professional Standards as soon thereafter as is practicable, and
- (b) Whenever a Church Worker applies to renew his or her endorsement under the *Safe Church Communities Program*, he or she must confirm that all Disclosable Matters have already been reported or report any Disclosure Matter that has occurred since the last renewal.
- 5. Schedule 1 of this Ordinance may be modified by decision of Diocesan Council, acting on the advice of the Professional Standards Committee.
- 6. Nothing contained in this Ordinance shall derogate from the rights and privileges of the Bishop of Tasmania.

SCHEDULE 1 Amended 2010, 2011, 2013, 2014, 2016, 2020, 2021

REQUIREMENTS FOR SAFE CHURCH COMMUNITIES ENDORSEMENT BY CHURCH WORKERS

All persons seeking Safe Church Communities endorsement must satisfactorily complete a Safe Ministry Assessment which involves (a) completing and lodging the required forms, together with evidence of a current State Working with Vulnerable Card, and a National Police Check where required, (b) obtaining suitable references and (c) satisfactorily completing the training designated in the table below.

The Diocese does not endorse persons under the age of 16 years as Church Workers.

Forms and supporting documents are lodged with the Diocesan Professional Standards Unit.

The Director of Professional Standards or authorised delegate as per Clause 11, National Register Canon 2007, will carry out the National Register checks.

A person holding multiple roles must maintain the highest level of endorsement required for any role they hold. Re-endorsement is required every three years.

(Any additional requirements for re-endorsement will be published by the Diocesan Council from time to time on the advice of the Professional Standards Committee.)

This Ordinance operates alongside and in addition to the *Safe Ministry to Children Canon 2017*. The requirements of this Ordinance take precedence where these differ from those of the *Safe Ministry to Children Canon 2017*.

For this Ordinance, in accordance with the 'Professional Standards for The Protection of Children and Adults from Sexual Misconduct Ordinance 2005:

'Church worker' means a person who is:

- a) A member of the clergy; or
- b) A person employed by a Church Body; or
- c) A person holding a position or performing a function with the actual authority of a Church authority or Church body.

'Church authority' means the Bishop or a person or body having administrative authority of or in a Church body to license, appoint, authorise, dismiss or suspend a Church worker.

'Church body' includes a parish, committee, unincorporated association or unincorporated organisation that exercises ministry within, or on behalf of the Church in Tasmania.
